PRIVACY POLICY DOCUMENT.

We are committed to safeguarding the privacy of our website visitors; this policy sets out how we will treat your personal information. You can visit the Website without disclosing any information about yourself. 1. What information do we collect?

You expressly agree to such transfers of personal information.

6. Security of your personal data

We will take reasonable technical and organisational precautions to prevent the loss, misuse, or alteration of your personal information.

We will store all the personal information you provide on our secure (password- and firewall-protected) servers. All electronic transactions you make to or receive from us will be encrypted [using SSL technology].
